II. COMMITTEE DESCRIPTIONS

Chapter Chair

- Represent the SFV chapter of Climate Reality and oversee chapter activities.
- Liaise with Climate Reality managers and partner climate organizations.
- Report to and coordinate with the Climate Reality Project supervising team on other chapter business.
- Schedule and run monthly chapter meetings and, in coordination with Programming, book speakers.
- Along with Vice Chair, support activities of committee coordinators.
- Along with the Vice Chair, provide oversight for committees and pods.
- Lead monthly meetings for the SFV Leadership team.
- Guide the leadership team and chapter along the chapter's strategic plan and mission.

Vice Chair

- Assist Chair in running the inner workings and organization of the chapter.
- Submit monthly chapter report to CRP.
- Facilitate administration of chapter calendar.
- Lead the book club.
- Coordinate newsletter and digital communications schedule.
- Work with other chapter leaders on their various committees and pods.

Outreach

- Increase chapter membership and maximize attendance at chapter-led events.
- Lead and involve other chapter members in identifying and utilizing all possible conduits to publicize environmental information and invitations to chapter meetings and events.
- Develop and sustain conduits through community resources.
- Update weekly Climate Reality opt-in members.
- Contribute to Chapter press releases.

Legislation

- Maintain ongoing communication with legislators and their environmental aides throughout the state.
- Share with CR members new and important environmental legislation that may be coming up for a vote, and recruit members to take part in advocacy opportunities.
- Evaluate local and statewide legislation for endorsement by the chapter.
- Coordinate with other activist groups to support climate friendly actions and legislation.
- Promote and facilitate communication between local legislators and their constituents within the CR community.
- Invite legislative guest speakers to CR meetings for updates and presentations.

Member Mentoring

- Provide a resource for SFV chapter members seeking one-on-one advice, support, and/or encouragement on matters pertaining to their activism. (It's not a requirement to be a trained Climate Reality Leader.)
- Cover everything from a one-off question, a request for feedback on a work-in-progress presentation, a blog-post proofread, or merely a booster shot of climate hope!
- Chapter members who have opted into the SFV Chapter are eligible to arrange a phone or Zoom meeting with the chapter's mentor for specific feedback or general encouragement.

Graphic Designer

- Act as a graphic design resource for the chapter
- Source, download, and create text information and images needed for the design and execution of visual promotional items including:
 - o Monthly chapter meeting fliers
 - o Committee social media campaigns
 - Community informational fliers
 - Book club meeting announcements
 - o Templates for ongoing committee meeting announcements
 - Volunteer opportunities announcements

Events Coordinator

- Identify inclusive activities for chapter members, family, and friends that encourage and increase membership and participation in chapter-led events.
- Create a calendar of suggestions and ideas for in person climate reality actions, activities and engagement

- Welcome and encourage other chapters, partners, like minded organizations and non-members to participate in shared activities.
- Share community resources and events for smaller group participation.
- Support Climate Reality goal of inclusion, education and advocacy of Climate activities, actions and events.
- Seek on-going input and feedback from chapter and participants and communicate calendar and updates

Treasurer

- Maintain a financial balance sheet for the chapter.
- Oversee incoming and outgoing chapter financial transactions.
- Develop a fund-raising strategy and schedule events to support chapter activities, such as purchase signs, cards, and other materials needed for ongoing outreach.
- Oversee chapter donations, both internally and through the website.

Programming

- Support the chapter mission to educate and advance our understanding of the climate crisis and how we can effectively fight it.
- Obtain input from the chapter members and leadership team as to what educational topics would be helpful and appropriate.
- Meet monthly with the Programming pod to plan and/or help coordinate the guest speaker presentations for the monthly chapter meetings.
- Coordinate supportive educational opportunities with other Committee Coordinators.
- Produce programs for chapter meetings.

Partnership Communications and Engagement

- Engage with outside organizations and chapter members to build relationships across and within Campaigns to strengthen our collective communities.
- Support in drafting communications with partner orgs new and old.
- Coordinate volunteer opportunities to participate with local and partner orgs on campaigns and projects.

Environmental Justice and Rights of Nature

- Expand awareness in the SFV Chapter of environmental justice issues in the SF Valley community.
- Bring rights of nature to the forefront through pods, education, and/or activities.
- Support efforts to help those communities that are being burdened unfairly due to climate issues.

 Stand with community climate organizations and defend the act of fairness in all environmental policies.

Newsletter

- Gather content for next newsletter
- Connect with Chapter Meeting "Producers" to get up to date content
- Produce two newsletters a month
- Create additional Newsletters for specific topics (book club, Call to Action, etc.)
- Find additional ways to support the SFV CR team (including working with digital communications)

Digital Communications

- Create and maintain the chapter website, keeping it up-to-date with accurate information regarding upcoming meetings and events.
- Direct communication that arrives through the website to the appropriate member of the Leadership Team.
- Use the chapter's social media accounts (Facebook, Instagram, and Threads) to share relevant information with chapter members and provide them with content to share easily with their personal networks.
- Build the chapter's social media following to expand awareness of our chapter's activities throughout the San Fernando Valley and attract new members.

Sustainability Advocate

- Monitor and report on local sustainability issues and opportunities to the Chapter.
- Share Sustainability tools/resources such as the City's Green New Deal NC toolkit advisory guides.
- Educate and work with existing Chapter committees and pods as necessary to further sustainability goals.
- Be a liaison between the Neighborhood Council Sustainability Alliance and the Chapter.

Zero Waste Advocate

- Provide guidance and information on zero waste behaviors and practices that can be employed by chapter members
- Consult on, educate and advocate Zero Waste practices
- Present documentation and reports on current zero waste actions (at all levels)
- Initiate and coordinate Zero Waste efforts and initiatives

- Monitor Zero Waste initiatives
- Advocate policy and legislation relevant to zero waste objectives
- Partner with the Legislative Committee to advance Zero Waste initiatives

III. CANDIDATE INTRODUCTIONS

Sean Carlin (Member Mentoring)

Sean Carlin is an author and blogger, as well as a founding member of the SFV Chapter of the Climate Reality Project. After training as a Climate Reality Leader in 2018, he worked directly with the Chief Sustainability Office of Los Angeles to bring L.A. into the County Climate Coalition, a nationwide alliance of local jurisdictions committed to upholding the standards of the Paris Accord. In addition, he has given public presentations in support of federal climate legislation, which we finally got in 2022, when President Joe Biden signed the Inflation Reduction Act, an historic investment in green infrastructure, into law. Having relocated to his hometown of New York during the pandemic, Sean now serves as the SFV Chapter's Membership Mentor.



Tara Sitser (Graphic Designer)

Tara's love of nature and awareness of animal rescue issues began when she was a child. Seeing a circus on TV was, at first, magical but then, even as a 5 years old, she worried that the animals weren't being treated well.
